**V. 1<sup>st</sup> Vice President-** Burgers and hot dogs have been ordered for August 9, 2022.Candy will be purchased from Sam's. Mobile ordering is still being discussed.

**VI. 2<sup>nd</sup> Vice President-** Rubbermaid containers are needed to store the old uniforms. The Cushing's church wants to help with feeding the kids for away games. Cleaning up after the meal will need to be organized. We will still feed the students after the game for home games. Chaperones will still be held at a minimum. Rain ponchos need to be ordered.
