**Article and Title:** Article 8, Section 1

**Currently Reads As:** 8.01 Meetings will be held monthly on the third Monday in each month at 7:00 p.m. at the Southside High School Band Room or at such other place as may be selected by the Board of Directors.

**Proposed Amendment:** Revise Article 8, Section 1 to Read:

The suggested, but not requires dates are: May Orientation Meeting, July Pre-Camp Meeting, October Fall Concert, February MPA Preview Concert."
